the bird walked through the weeds taking long steps feeding. Seeming to be unafraid. It looked for food in the shallower parts of the pond.

Describe in detail the bird's relative size, overall shape, plumage and color pattern.

Include details of bill, wing and tail shape. Give particular emphasis to marks you used to identify the bird. Reference to its resemblance to field guide descriptions and illustrations is not enough. Describe only what you actually observed in the field:

Size: a little smaller than the leghorn chicken and also about that shape. Plumage was very different; the coloring seemed more blue than purple with white under tail coverts. The bill was red with yellow tip (about 1/2 way of the bill) and white above the red, or nearly white. The bill is shaped like a chicken's bill. Its legs were bright yellow, with long toes, also yellow.

Describe the general and specific habitat in which you observed the bird: *It was in a Pond, fairly shallow with some kind of growing waterplants. the bird fed and waded among this growth.*

How did you eliminate similarly appearing species? *the Common did not have the white above the Bill nor was it nearly as colorful. Markings different. there is no other bird quite like the Purple Gallinule.*

What is your prior experience with this and similarly appearing species? *I have seen the Common Gallinule in a pond So. of Phoenix, ARIZ. several times.*

Light was to our right from the west in late afternoon 3PM and excellent visibility

Describe the bird's behavior (e.g. flying, feeding, or habits used in identifying):

Feeding on the pond lilies, stepping on the pads, reaching forward to grasp the far side and roll the far sides of the leaf then would daintily hold one foot on the leaf and pick the bugs. Was exceedingly unconcerned and was the only inhabitant of the small pond.

Describe in detail the bird's relative size, overall shape, plumage and color pattern.

Include details of bill, wing and tail shape. Give particular emphasis to marks you used to identify the bird. Reference to its resemblance to field guide descriptions and illustrations is not enough. Describe only what you actually observed in the field:

Seemed about the size of a coot or perhaps a bit larger-plumage was brilliant- bill was reddish orange- tipped with yellow- frontal shield was a vivid blue- head and underparts bright purple back and wings bluish green iridescent- legs and feet yellow- under tail coverts white and stri as it bobbed up and down when tail was elevated.
