Bird flushed from small group of cattails by dog. Bird flew towards me and landed in water then walked into cattails 10 feet in front of me. Bird then flew, low over the water into a large marsh. All the flights were low and very short (less than 10 feet)

Bird was smaller than a redwinged blackbird, about the size of a house sparrow. The bill was black. It had a very short tail and stubby wings. There were white spots on the back and a small rusty patch on the back

Describe the bird's song and call, if given, including method of delivery, (i.e. from perch, in flight, duration):

Describe the general and specific habitat in which you observed the bird:

A large marsh interspersed with several cottonwood trees, old gravel pits and small islands. Bird was seen in ~~old~~ cattail swamp near a long shallow slough with standing water, no fresh water.

How did you eliminate similarly appearing species?

Sora has yellow bill and is larger.
Red-winged blackbird is larger, has longer tail, shorter bill and don't sit in cattails in the water the way the rail did.

What is your prior experience with this and similarly appearing species?

Have never seen Black Rail although I thought I saw one in same area April 12 but did not get a good look at it. I have seen several Sora's and know their appearance and behavior. I have extensive experience with red-winged blackbirds.
