MEDIUM SIZED WOODPECKERS. RED PATCH ON HEAD, WHITE FOREHEAD, CHIN AND LOWER CHEEK. BACK OF FACE WAS DARK. LIGHT EYES WERE EASILY SEEN. DARK WINGS AND BACK, BUT WHITE RUMP AND PATCHES IN OUTER WING SEEN IN FLIGHT. DARK UPPER BREAST, WHITE LOWER BREAST AND BELLY, WITH STREAKING ON THE FLANKS. THE EXTENT OF RED ON HEADS AND BIRDS GENDERS WAS NOT NOTED.
