Diffused light; late afternoon, early evening, in shaded area

Who else photographed the bird? no one

Describe the bird's behavior (e.g. flying, feeding, or habits used in identifying):

The hummingbird was perched on the end of a small trunk of a bush. It would make a loud clicking sound ("click-click") and then fly to the feeder. Each time he made that sound, he was flying to the feeder.

Describe in detail the bird's relative size, overall shape, plumage and color pattern. Include details of bill, wing and tail shape. Give particular emphasis to marks you used to identify the bird. Reference to its resemblance to field guide descriptions and illustrations is not enough. Describe only what you actually observed in the field:

The bird was noticeably larger than other hummingbirds in this area (Broad-tailed, Black-chinned and Rufous), and the tail seemed longer. It was green with ~~violet~~ violet and blue patches on its face and breast (see Exhibit A). The bill was slightly down-curved, the wings dark, or black, and the tail long with dark band near the end. (See Exhibit B ~~for~~ wings and tail)

The loud clicking sound was attention-getting and I knew it was something different.

Description (continued):

Describe the bird's song and call, if given, including method of delivery, (i.e. from perch, in flight, duration):

"Song" was a loud insect-like double click and was given when leaving its perch and flying to the hummingbird feeder. It lasted only a few seconds and was given two or three times each time it left its perch and fed.

Describe the general and specific habitat in which you observed the bird:

Riparian and landscaped backyard.

How did you eliminate similarly appearing species?

Did not have eye stripe (white) or white on end of tail as a Blue-throated;
Did not have green throat or purple crown as Magnificent;
Did not have red bill or blue gorget as Broad-billed.

What is your prior experience with this and similarly appearing species?

This was the first time I have ever seen a Green Violet-ear. I have seen the above mentioned species several times at Cave Creek, Arizona.
