BIRD APPEARED NEARLY SIZE OF BROADTAILED HUMMINGBIRD
BACK AND WINGS WERE GREEN, BREAST GRAYISH, CORSET AND
FOREPART OF HEAD RED (IN PROPER LIGHT AND ANGLE) THE
BILL WAS DARK, A LIGHT, ALMOST WHITE AREA OBSERVED NEAR
SHOULDER - SMALL, ROUNDED TAIL.

THE RED FOREHEAD WAS A MOST DEFINITIVE MARK. I FIRST
OBSERVED THE BIRD BY MYSELF AND THOUGHT IT POSSIBLY A
BROADTAILED (I HAD NOT BEFORE SEEN AN ANNA'S), BUT SUDDENLY
IN PROPER LIGHT AND RIGHT POSITION I COULD SEE THE RED
