Observed with Mallard, feeding in small irrigation ditch. Alert immediately when stopped. Flew (with Mallard) when an approach was made.

Bird shaped very similar to nearby Mallard except forehead seemed flatter with respect to top of upper mandible. Size, same or nearly same as Mallard.

Body plumage: black brown, much darker than female Mallard; head gray, contrasting with body. Bill entirely yellow. In flight, underwings white, strongly contrasting with under body (belly and rest of under body dark). Speculum appeared all dark. Did not see any white in the tail when in flight.

Describe the bird's song and call, if given, including method of delivery, (i.e. from perch, in flight, duration): N/A

Describe the general and specific habitat in which you observed the bird:
Ditch (shallow) within agriculture areas near small ponds and one large reservoir

How did you eliminate similarly appearing species?

Female mallard, shows white on speculum and tail, bill is not all yellow, body plumage too dark. Mallard show light on upperparts in flight. Female mallard lacks contrast between body and head.

What is your prior experience with this and similarly approach:

Black Ducks - seen hundreds (and studied them) on coast of North Carolina.
