Describe the general and specific habitat in which the bird(s) occurred: Along an open strip of water—20 ft wide or so—on a frozen lake.

The bird fed actively, swimming with its head submerged as a loon does, and occasionally diving.

A mid size grebe with muted brownish gray plumage. Head smoothly rounded. Cap and hind neck dark brown or blackish. Back darker than breast, neck, and head. A hint of a white chin strap. Large, straight, yellowish bill. Underparts whitish. See attached photo.

Describe birds call or song: Silent.

Discuss similar species and how you eliminated them: The large yellowish bill is quite unlike any other grebe, and the bird was much smaller than any loon.

What is your prior experience with this and similar-appearing species? I had not seen this bird in this plumage previously.

List books, guides, recordings or other sources consulted and how this influenced your identification (during and after observation): National Geographic, Peterson Western. Confirmed immature plumage.
