when the bird flew up from the ground I first noticed the long brown tail + slender wings. I did not observe any tail spots (from behind) or any rufous in the wings. It landed in a willow. I could see its bill was all dark at that time I could not see its eye. The tail was all brown (from behind- I did not get a view under its tail at all). I had a good view of the folded wings and could not see any rufous at all. The bird flew into a Juniper and I got a very long look at the ^{slightly curved} black bill and the red orbital ring which then confirmed I was looking at my first Colorado Black-billed Cuckoo.

No call or song heard

SIMILAR SPECIES -- This is another critical part of your report. Please discuss how you eliminated similar species from consideration.

Dave Johnson saw the bird the day before + saw the all black slightly curved bill but not the red orbital ring nor did he get a good look at the brown wings. He could not eliminate Juvenile Yellow-billed although a juvenile at that time of year would be unlikely.

I got a good look at the all brown wings and the red orbital ring which eliminates yellow-billed Cuckoo (and Mangrove Cuckoo). Although I did not get a look at the small white tail tips - that feature was unnecessary for confirmation after seeing the red orbital ring.

What is your prior experience with this and similarly appearing species?

I have seen many Yellow-billed Cuckoos in Colorado + Black-billed Cuckoos in Minnesota
