Describe the general and specific habitats in which the bird(s) occurred: mature deciduous trees, close together, forming a canopy in much of the several acre campground. Surrounded by grasslands and high dessert plant life, with nearby reservoir.

The bird flew while I was radioing others. Bird perched in a different tree out of my view, but was seen by other observers mentioned.

The bird was obviously a cuckoo, based on its shape, size, bill size and overall coloration. The bird was long and slender, approximately 12 inches, with approximately 1/3 of his length being tail. The bill approximately 3/4 inch, was dark, with a curved upper mandible, and slightly curved lower mandible. The bill was similar in shape and size of Yellow-billed Cuckoo. The lower mandible was closely examined, and was dark, with no yellow or paleness. The throat and underparts were white or whiteish. There were no markings in any of the white underparts. The head color was dark, along with what I could see of the remaining the upperparts, appearing greenish gray including the wing color. There was no noticeable rufous seen in the folded wing, or during flight. The dark head color came to just below the eye and was sharply delineated from the white below the eye. The bird had a noticeable, bold red eye-ring. I did not notice the undertail color or pattern before the bird flew.
